The team would also love to hear from the community regarding any positive or negative feedback that you may have or any issues or concerns that you may wish to raise.

SPEEDING:

The Speed Indication Device (SID) and residents using the Community Speed Watch (CSW) have been deployed in several areas.

On the 13/04/2011 speed enforcement was conducted on Brimmers Hill, Widmer End, 4 fixed penalty tickets issued.

Windmill lane was subject to the Community Speed Watch on Saturday 23rd April, with a total of 43 vehicles passing through. 24 of the vehicles were above the threshold and will receive a letter regarding the speed. The top speed recorded was 55mph. The average speed recorded for the road was 35mph.

The T-Sid was located on Copes Road Great Kingshill the speed was monitored 24hrs a day over a 2 week period with the following results;

20262 Vehicles passed within the period.

7842 Vehicles recorded above the threshold for enforcement.

33 Was the average recorded speed.

SID was placed along the Warrendene Road on 12 April, however the sun was shining bright and causing driving difficulties, this in turn reduced the speed of the travelling vehicles dramatically. The average speed was well below the permitted 40mph at only 31mph. only 7 vehicles were slightly above the limit.

Naphill is scheduled to have CSW and SID within the last week of April, post submission of this newsletter. The report will be in the next newsletter.

T-SID has been approved for 3 deployments, Widmer End, Naphill and Hughenden Valley. Bucks Highways will position them in strategic positions that have previously been highlighted as hotspot areas for excess speed.

Three dates have been set for the **MAY** period, the locations are yet to be established but each ward will have at least 1 SID deployment over the period. If you are interested in seeing how the device works or

you are interested in becoming involved in the process please contact Natalie HALL or Lee Turnham at the above address or e-mail. We will then be able to inform you of the location and time that is appropriate to your ward.

LITTER:

There has been a marked improvement throughout the parish, with the good weather residents have cleaned up outside their homes. The main place for litter is around the common at Great Kingshill. This is mainly because the youths are gathering and leaving bottles and fast food wrappers. This is being addressed under Anti-social behaviour.

PARKING:

The areas around the schools seem to have calmed down a little. With a long break in the schools holidays the issues have been watered down. When the schools return officers will be on hand to monitor any complaints and take necessary action if needed.

Parking in general is good within the parish. The parking issue at Warrendene Road, the vehicles delivering to Country supplies, has resulted in 3 fixed penalty tickets being issued to the drivers. This has not been received well by the companies. If the situation continues then more tickets will be issued.

OTHER MATTERS;

PUBLISHED COURT RESULTS;

Oliver DUNN of Main road Naphill has been disqualified from driving for a period of 55days. He was also fined £70 and ordered to pay costs of £80. The case related to excess speed.

Michael NICHOLS of RAF Naphill has been disqualified from driving for 12 months. He was also fined £250 and ordered to pay costs of £100. The case related to Drink Driving.

ANTI-SOCIAL BEHAVIOUR;

There have been 2x section 59 warnings placed on Motor cycle riders, these persons were caught riding off road bikes across the Terriers Farm land at the back of Widmer End Village Hall.

There is an operation in order in relation to ASB around the common at Great Kingshill. Youths have taken the good weather as a green light to hold gatherings around the commons edge. Playing Loud music and leaving enormous amounts of litter and empty bottles when they leave. It seems that most of the youths are local to the village and don't realise the impact on the community. The Police operation will run as long as it takes these youths to realise that this practice is not acceptable.
