5. Chairman's Report:

The Chairman (Paul Cawte) read his report, (a copy of which will be printed in the Newsletter).

The Chairman opened his report by thanking all road representatives and members of the committee for their valued support and assistance over the past year. He outlined the involvement the Association had in the various village events which have included the Potter Cup Quiz, the Senior Citizens Event, the Village Hall Bazaar and the Village Day. In particular he thanked those members who helped to make these events successful.

The Chairman reviewed the current progress being made in the area of road safety including the proposed pedestrian crossing.

His report then considered crime prevention and vandalism in the Valley and he described the measures that were being taken and the close link being forged with the local Police.

In describing the work of the Planning Sub-committee he thanked Dory Morgan and Rosemary Hewitt for their tireless work in looking into planning issues that may influence the Village.

The Chairman thanked Lynn Sullivan for her work as editor of the Hughenden News publication which has been restyled and now included colour. He also thanked Robert Ralphs for his work on the website and Janet Idle for her regular contributions to the Bucks Free Press on information about the village. The projects that the Association has been involved in over the past year have included maintainance and refurbishment of the bench seat adjacent to the Village

Hall and a grant to the Ecology Working Party to support their volunteer work. The Chairman concluded by thanking Graham Atkinson, the outgoing Treasurer for the time and effort he has given the Association over the past few years.

6. Treasurer's Report.

The Treasurer (Graham Atkinson) presented the Accounts for the past 12 months, which had been audited by Nigel Lanchbury (circulated).

He clarified the position of the two accounts and went through the sources of income and expenditure that have occurred in the year. This included mention of a grant received from the Parish Council towards the cost of the newsletter and a

grant given to the Village Hall to help towards the maintenance of the landscaped area above the football field.

He noted that this year the income has exceeded expenditure by £556.70, giving a balance of £5,227.47.

He stated that it had been agreed that subscriptions would remain the same again for this year, being £3.00 per household or £1.00 where the household included a senior citizen.

The Treasure concluded his report by thanking Edna Parker for her efficient work in collecting advertising revenue and to the road representatives for collecting the subscriptions and 100+ club subscriptions.
