Due to a fault with the SID equipment, there will be no allocated Community Speed Watch dates set until further notice.

The SID has now been delivered to the repairers; we hope to have the device back asap.

CRIME WITHIN THE PARISH;

Criminal Damage to a building in Widmer End.

Theft of a mini digger from Hughenden Valley.

Theft of a wallet from Four Ashes road.

Burglary non-dwelling; garden tools taken from a shed in Limmers Mead

Theft of gardening tools from the allotments in Widmer End

Theft of military items from a dwelling in Windmill Lane.

Burglary non dwelling; garden tools taken from a dwelling in Warrendene road.

Burglary non dwelling; electrical items taken from a garage in North Dean

Criminal Damage took place at Grange road Widmer End.

Criminal Damage to 2 vehicles in Warrendene Road.

Burglary to a commercial premises in Great Kingshill; alcohol was taken.

Criminal Damage on two vehicles took place on Cryers Hill Lane Cryers Hill.

However, there are other reports that come into the Police, these may be related to crimes or recorded due to their nature.

ANTI-SOCIAL BEHAVIOUR;

There has been little ASB within the parish although an issue is being dealt with by a joint partnership with Police and Housing associations. The issue is taking place in the Walters Ash area where a local resident is playing loud music and drinking vast amounts of alcohol. The housing team from High Wycombe are liaising with residents in the area and Police are paying visits to the individual in order to curb the noise. There are now dedicated resources that attend all reports of ASB within the High

Wycombe police area. These resources have a positive intervention policy, dealing with the incidents with the legislation and tools available at the time.

There have been complaints from residents living near to a few public houses, the main problem is that of bad and inconsiderate parking at weekends and also the noise coming from the garden areas when the weather is fine. Officers have been to the locations and spoken with the landlords and staff about the problems raised.

OTHER MATTERS;

Changes within the Neighbourhood came into effect from 01st October 2012. This will not change the way in which Policing is delivered to the parish. The Greater Hughenden Parish will now be policed by the neighbourhood team from Princes Risborough. I will inform all recipients of my new contact numbers and address in an e-mail as soon as practicable. Direct line telephone numbers will change from 01494 to 01296, numbers to follow. New team posters will be made and placed around the community.

Parking:

With the school term now started the parking issues at schools have risen. Many schools were built prior to the housing estates and road networks being what they are now. Road safety takes paramount priority however, this is not to be taken out of context when parking issues overtake resident's ability to go about their daily lives. There have been numerous reports that parents are parking in places that they regard as safe locations rather than allowing consideration to residents and other road users. Parking on junctions and on pavements with tactile paving seems to have become the norm. The Highway Code has a section on the 10M rule of junction parking, and the tactile paving is there for the visually impaired. Please look at the Highway Code, even if it is to gently remind yourself as to the basic rules of motoring.

There is an element of safety that should be adhered too, when taking children out of a vehicle and into school etc. Please remove the children from vehicles by using the pavement side of the vehicle and allowing the children to stand on the pavement and not on the road.

Have you Signed up to Thames Valley Alerts?

Thames Valley Alerts is the new system for receiving crime and policing updates for your area. The state-of-the-art system allows anyone who signs up to choose what updates they receive and how they would like to receive it. A new option includes receiving information via text and more traditional landline and email messages will still be available. You can also filter the updates you receive by specifying the priority level of the messages you receive.
