3 APPROVAL OF THE MINUTES OF THE LAST MEETING:

These were adopted as a correct and true record of the February meeting. The vice chairman welcomed Councillor David Carroll to the meeting

4 MATTERS ARISING:

- Jerry Morley reported that Richard Pushman had approved the expenditure for road repairs for Walter's Ash and Naphill Main Road (but not Coombe Lane/ Hughenden Valley).
- John Miller raised again the issue of road marking with red paint at the bottom of Coombe Lane funding had subsequently been withdrawn by BCC.
- It was reported that Richard Pushman had pledged for the lollipop scheme.
- Secondary signs (re School) had been provided to slow traffic along Valley Road.

Road items.

Concern was noted about HGVs hampering the progress of permanently keeping potholes filled. David Carroll promised to talk to Richard Pushman about several items raised in the discussion concerning the future Highways funding for Hughenden Valley. It was felt that children should know the risks/rules of where to cross the roads.

5 TREASURER'S REPORT

Al Bowyer said there were fewer advertisers for the Hughenden News, due in some measure to businesses failing. There is just over £4140 in the HVRA account. He did not recommend raising the senior citizens membership fee to £5 at this stage but did recommended that road reps try to collect outstanding subs and encourage new membership.

In future there could be more pressure on the use of local land and consequently more pressure on the Fighting Fund. A question was raised regarding the minimum level of the Fighting Fund and what it would be used for. All would produce a report to discuss at the next meeting.
