CONFIRMED MINUTES

Action

Janet welcomed Cllr David Carroll, District & County Councillor, and Sarah Cormack who has volunteered to be the new HVRA Secretary.

- **2. APOLOGIES FOR ABSENCE** were received from Clare Atkinson, Al and Christine Bowyer, Anna Burniston, Heather Dempsey, Karen Dynes, Virginia Foster, Alison Geiler, Jerry Morley and James Perkins.
- 3. CONFIRMED MINUTES OF 7TH OCTOBER 2014 were formally signed off by Angus having been circulated and put on the website.

THE MINUTES OF THE LAST MEETING HELD ON 4TH NOVEMBER 2014 were read and signed as a correct record subject to the following amendment: **12.1.** "Affinity" should be "Infinity".

7. VISITOR - COUNCILLOR'S REPORT

Cllr Carroll thanked the HVRA and the community for their continued support despite the difficult economic times. He congratulated the residents involved with the Hughenden Valley Drainage Improvement Group (HVDIG), and praised the progress it has made with the cascade communication structure that is in place to alert the relevant agencies e.g. Thames Water, the Environment Agency and BCC, which is now a template for other sewage-affected areas in Bucks. An on-going survey is being carried out in the village and the ditch near the pumping station needs to be dug out. He was pleased that every two to three months they all get together so that residents can ask the Agencies what have they been doing? He thought the HVDIG article in the recent HVRA magazine was excellent.

He supported the Village Shop and the proposed Cabin for which he has donated £1,000. He was delighted to accept Louise Jones' invitation to attend the launch of *The Cabin* at 4pm on Sunday, 14th December.

He had spent a lot of time lobbying BfT to get the roads resurfaced and apologised for the challenge that the road closures had caused. At the moment Hampden Road is closed for patching-up and works to Perks Lane will be carried out next year.

In response to his request for questions, Janet reminded him that Valley Road (A4128) needs attention because its surface is very noisy and above EU levels. On the question of the overgrown hedge at the top of Perks Lane the Local Area Technician (LAT) has written to the householder requesting it be cut back but if it is not then BfTwill carry out the work and send them the bill.

Linda Derrick who represented the residents of Hughenden Valley on the Parish Council had resigned and a replacement is now sought.

8a. | Village Hall Bazaar Tombola – Feedback

Sara thanked all the helpers very much indeed. She was pleased that the tombola was very busy although there were slightly less items this year with takings of £150, down on last year's of £180. Unfortunately, the Village Hall Committee did not advertise the event. It was felt that the format needed to change and become more of a Christmas Market/Craft Fair. 8b. Cabin Furniture Painting, 6 and 7 December, 10am – 4pm

Louise acknowledged receipt of the £500 cheque from the HVRA and one for £2,500 from the Village Hall Committee for which she was immensely grateful, and reported that the shell of *The Cabin* was already up. She detailed the programme of works to be carried out over the following days, with a painting party over the weekend of 6 and 7 December. Martin Richardson is installing the electrics free of charge, B&Q are giving a discount on the floor and James Aitken will be laying it etc. Buildbase will be supplying the wood for the ramp and any supplies needed. As all the furniture will be stored in her garden shed she will need help to carry and load it into her trailer. Gill Graham and the scouts have offered to help too.

8c. Christmas Tree Lighting & Carols, Sunday 14 December plus proposed Cabin Launch – subject to planning permission.

Louise said the Christmas tree lights will be off until Sunday 14th December. The launch will commence at 4pm when the lights will be switched on and the children from Hughenden Primary School will lead the carol singing, after which *The Cabin* will be formally declared open.

Janet will write, on behalf of the HVRA, to the Parish Council and the Village Hall Committee to thank them for their donation of £2,500 each, and to Cllr David Carroll for his £1,000 donation which collectively has made this project possible for the benefit of the community. Also, help will be needed to sweep out and keep *The Cabin* clean and tidy and perhaps Road Reps might be able to provide this ongoing help.

9db. Allotments

James has written an article in the HVRA magazine about the Charity, Allotments for Labouring Poor, (AfLP). Janet and Angus have written on behalf of the HVRA to the Charity Commission (CC) and the Secretary of the AfLP with their concerns, and have received a reply from the CC with numerous attachments detailing the background to this complex issue which dates back to 1855 and 1862. The Scheme will not change the ownership of the land because it has always been owned by the Charity and not Hughenden Parish Council. Angus is pleased that there will now be a minimum of 4 Trustees but he is not happy with the administrative structure of the reformed AfLP and a meeting will be held with Janet, Rosemary and David Sharp to discuss an appropriate response to progress this matter.

They have cleared off all the vegetation and have asked Jill Ayres, a local geologist, to take a look as it could be of local geological importance.
