In the last month, a new developer has expressed interest. There will be a meeting with the new owner Thursday 9th July at 2:30pm. They have invited JI & AI, Co-Chair stakeholders for HVRA and Hughenden Valley. But not the Chiltern Society. But they are going anyway. The Wycombe Society is going.

For information - Bucks Garden Society are carrying out a survey of the ancient ornamental gardens at Uplands (Garden information from Marion Miller).

11.c Bryants Bottom - Stables.

Road rep will monitor compliance with the conditions set by WDC.

12 ROAD REPRESENTATIVES' REPORTS

JD noted concern over the state of the road surface on Trees Rd. GW has tried in the past to get all residents to contribute.

BCC/WDC cannot help, as it is private road.

DH reported that on Cryers Hill a horse chestnut tree has been cut down with no notice.

Valley Rd, Church Farm end, following the verge being cut, the rubbish on the verge is now much more visible. The verge was cut within one day of last years cut, so it appears to be on a regular schedule for TfB. JI to write to Michelle Jennings if necessary. Noted that there may be a change in law to prosecute driver of the car, & not have to prove who actually threw the rubbish.

GW noted that the rain water drains at the bottom of Trees Road have still not been cleared.

AI noted that part of the road surface at the entrance to the Manor has broken up.

AI noted that there are mobile displays on the main roads running into High Wycombe. The resolution is poor, & the refresh rate is too fast. AI has written to TfB. A route 300 bus was spotted with misaligned headlights. Details were sent to Arriva.

Anna Burniston provided a written report, seeking clarification of ownership & management of trees between South Maundin & Valley Road.

Suggested that residents check the Land Registry to determine ownership & meet with the owner. RH offers to mediate/keep us up to date.
