3. APPROVAL OF THE MINUTES OF THE LAST MEETING HELD ON 1st OCTOBER 2024

10. ROAD REP REPORTS

c) Valley Road (south) - The cable that Giga Clear cut through many months ago has now been identified and James Tunnard, the Local Area Technician (LAT) is looking into the matter.

5. COUNCILLORS' UPDATES

a) Bucks Cllr Carroll

- i) In view of the new government's planned changes to Planning Policy to increase the Local Authority's housing target to 42% or 100,000 houses over the next 20 years, DC confirmed his commitment to protect this area of AONB and Green Belt, hoping the homes will be built on brownfield sites.
- ii) He had a fruitful meeting with the new Road Rep for Cryers Hill, Brian McCollum, and supports the Petition to reduce the speed limit from 50 40 mph. DC attended a meeting with Stan Jones, Chair of HPC, the LAT and the new Head of Gt Kingshill School regarding the school's request for Traffic Calming measures to include a 20 mph limit at the beginning and end of the school day.
- iii) He is pleased that by working with the National Trust and Bucks Council the road leading up to the Manor has been re-surfaced.
- iv) As a follow-up from his meeting with Jilly Jordan, at DC's request RH circulated her response and the Strategic Flood Management team's update to residents and DIG members.
 - DIG co-ordinator, PW, noted that they had not received any reports of significant internal property flooding to progress with further investigation and, along with numerous queries and some inaccuracies, he will respond accordingly.

- > JA asked how Bryants Bottom could be encompassed into the overall Hughenden Natural Flood Management Scheme bearing in mind the terrible flooding that numerous residents experienced three years ago and the engineering works that were carried out to remedy the problems and the remedial action that took place in Bryants Bottom.
- > JA invited PW for a cup of tea when she will show him the structural works that were carried out to mitigate against future flooding.

b) **HPC Cllr Kearey**

i. SK confirmed that the Memorial Plaque, previously sited on the front facade of the former Chapel in Bryants Bottom, has been installed on a concrete base on the grass verge opposite. The Remembrance Day service will take place there at 11am officiated by Major Glen Ridgeley whose 4 relatives died in the 1st World War.

- > Disappointment was expressed that after 7 years of working with the Parish Council, Major Ridgley has paid for the installation of the memorial plaque because of the time it takes the Parish Council to make decisions.
- ii. Recruitment of a Clerk has commenced; references are being checked and hopefully he/she will be in place in the next few weeks.
- iii. The Council has struggled to get on with things in the last few months because of lack of permanent staff in the office, necessitating the need for extra agency staff. A permanent Deputy Clerk and a Responsible Finance Officer are also needed.
 - > JA complained that the grass verges in Bryants Bottom have not been cut for a year and JH stressed that the hedges at the upper end of the village are very overgrown and restrict the width
 - > JA will pass on the emails of complaint to SK that residents have been writing to HPC for weeks.

iv. There are plans to rejuvenate the playground at Gt Kingshill and money has been set aside for Templewood's run-down playground.

- v. A Christmas get-together with community leaders and residents, similar to the one held at Church House last year, is being considered.
- vi. Cockpit Hole has recently been regenerated but there some H & S issues relating to the pond area.
- vii. SK referred to the HVRA seeking a £500 grant for the purchase of planters. Permission is required from Highways to put planters on Bucks Council land but it is for the Parish Council to buy them and for volunteers to maintain them, and if this is no longer possible then HPC to take over. SK will take this proposal forward as it is similar to the proposal from the Widmer End RA.
 - > It was queried whether the Parish will supply lots of daffodil bulbs as they did some years ago.
 - > As the £500 grant for the magazine has not been paid, SK to chase up and copy PW.

PW noted **the online flood questionnaire** which is monitored by a survey response team, and as residents need to be made aware of it, RH will pass on the link so that they can complete it when the interior of their homes become flooded in future.

A) CRYERS HILL – PETITION

After the last HVRA meeting, BMcC met RH in the Coffee Shop to discuss the best way to proceed with the Petition to reduce the speed from 50 – 40mph along the A4128 from Church Farm to the 30mph limit at the top of the hill.

- As Jackie Binning of the NWCCB recommended an online Petition, he has acquired all the email addresses of his residents in the road and at Church Farm.
- He has had meetings with Simon Kearey, David Carroll and Stan Jones, Chair of the Parish Council. Paul Nicholls, a former Chair of HPC, wishes to meet BMcC as he is involved with several road safety issues in Gt Kingshill.
- BMcC has met Suzanne Best, Head of Gt Kingshill School, and as the HVRA Petition aligns with theirs, she will be looking at the parents to sign.

- a) Power Cuts In view of the number of power cuts caused by branches falling across power lines and as this affects so many people, including the elderly and those families with medical needs etc, RH asked if she could get in touch with Road Reps to pass on Scottish & Southern's details so that people can register for their free Priority Service (www.SSEN.co.uk), giving their mobile number if possible, in order to receive extra support during a power cut.
- b) JA had seen a tv programme about the degradation of out-of-date hot water bottles that can suddenly perish when being filled with very hot water, causing severe burns or scalding. It is recommended that a water bottle is not filled with boiling hot water and to check the date that is imprinted in the area surrounding the screw top because it should be replaced every three years.
